**NOTICE OF APPLICATION / SEPA NOTIFICATION  
SHORELINE EXEMPTION - SDT2016-00051**

**Project Description:** Rebuild existing floating pier and make a fixed pile pier. Remove one existing 12 inch diameter woodpile. Install 6 four inch diameter galvanized steel piles and 2 six inch diameter galvanized steel piles. Raise pier so bottom of pier is 1.5 inches about OHWM. Replace solid wood-plank decking with Thru-Flow grated decking. Reduce overwater coverage by 6 six square foot from 402 to 396 square feet. No change in overall footprint.

On February 19, 2016 an application was submitted by ASHLEY SHORELINE DESIGN and deemed complete on March 10, 2016. On March 22, 2016, the City issued this Notice of Application/SEPA notification by the following means: mailed notice to property owners within 500 feet of the subject site, a sign posted on the subject site, and by placing a legal notice in the local newspaper.
