**AN ORDINANCE OF THE CITY OF SAMMAMISH,
WASHINGTON, AMENDING ORDINANCE NO. O99-15
FOR THE PURPOSE OF ADOPTING THE MOST
CURRENT EDITION OF THE UNIFORM PLUMBING
CODE**

WHEREAS, the Sammamish City Council enacted Ordinance No. O99-15, the City Building Code, in order to regulate buildings and construction within the City and to promote the public health, safety and welfare; and

WHEREAS, Section 26 of Ordinance No. O99-15 adopts the 1997 Uniform Plumbing Code, and

WHEREAS, the Uniform Plumbing Code adopted by Chapter 51-56 and 51-57 WAC shall become effective in all counties and cities of the State of Washington on July 1, 2002, unless local government residential amendments have been approved by the State Building Code Council,

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF SAMMAMISH, WASHINGTON, DO ORDAIN AS FOLLOWS:

Section 1. Ordinance No. O99-15 Amended. Section 26, of Ordinance No. O99-15 is hereby amended as follows:


Section 26. Adoption of the Uniform Plumbing Code. The Uniform Plumbing Code (UPC), 2000 Edition, excluding chapters 11,12, 15 of the Code, including Chapters A, B, D, H, and I of the Appendices and the Uniform Plumbing Standards, 2000 Edition, as published by the International Association of Plumbing and Mechanical Officials, as adopted by the State of Washington pursuant to Chapters 51-56 and 51-57 WAC, are adopted by reference.

Section 2. Severability. Should any section, paragraph, sentence, clause or phrase of this Ordinance, or its application to any person or circumstance, be declared unconstitutional or otherwise invalid for any reason, or should any portion of this Ordinance be pre-empted by state or federal law or regulation, such decision or pre-emption shall not affect the validity of the remaining portions of this Ordinance or its application to other persons or circumstances.

Section 3. Effective Date. This Ordinance shall be published in the official newspaper of the City, and shall take effect and be in full force five (5) days after the date of publication.


