ORDINANCE O2005-179**

**AN ORDINANCE OF THE CITY OF SAMMAMISH
WASHINGTON AMENDING SECTION 2.60.020 OF THE
SAMMAMISH MUNICIPAL CODE RELATED TO THE
APPOINTMENT OF MEMBERS OF THE CITY PLANNING
COMMISSION.**

WHEREAS, the City Council approved Ordinance 002003-122 creating a City Planning Commission, consisting of seven members, and designated that the initial terms of Commission members shall be staggered and shall end on March 31; and that subsequent terms shall begin as of April 1* ; and

WHEREAS, the City Council subsequently adopted Resolution No. R2003-151, appointing the initial members of the Sammamish Planning Commission, and designated that the subsequent Commission terms shall begin as of January 1; and

WHEREAS, the City Council desires to correct the conflict between the dates set forth in the ordinance and the resolution;

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF SAMMAMISH, WASHINGTON, DO RESOLVE AS FOLLOWS:

Section 1. Amendment. Section 2.60.020 Membership shall be amended to read as follows:


(1) . Number of Members. The Planning Commission shall consist of seven members. The term for all positions on the commission, except for the initial appointments, shall be for four years. Each term shall expire on ~~May 31st~~ December 31st of the last year of the term. In the event of a vacancy, persons appointed to fill the vacant position during the duration of the term for that position shall serve until the end of the unexpired term. The expiration date of the terms of the positions on the commission shall be staggered so that not more than four positions expire in the same year. Initial determination of four and two year terms shall be done by lottery. Four Commissioners will have four-year terms and three commissioners shall have two-year terms. The initial members of the Planning Commission shall serve as follows: four members shall be appointed to terms expiring ~~March 31, 2007~~ December 31, 2007; three members shall be appointed to terms expiring ~~March 31, 2005~~ December 31st, 2005. Subsequent appointments for full terms shall begin as of ~~April 1~~ January 1st.

Section 2. Severability. Should any section, paragraph, sentence, clause or phrase of this Ordinance, or its application to any person or circumstance, be declared unconstitutional or

otherwise invalid for any reason, or should any portion of this Ordinance be pre-empted by state or federal law or regulation, such decision or pre-emption shall not affect the validity of the remaining portions of this ordinance or its application to other persons or circumstances.
