Municipal Code (SMC)**

Notice is hereby given under SMC 24.25.160 that the City of Sammamish City Council will hold a public hearing regarding proposed changes to the Sammamish Municipal Code.

**SUMMARY of AMENDMENTS:** Amend SMC 21A.50, Environmentally Critical Areas, to extend the Sunset Provisions contained within SMC 21A.50.400. Certain provisions of SMC 21A.50 - Environmentally Critical Areas related to wetland, stream, and lake protections will revert to those in effect prior to January 3, 2006 unless the City Council takes action. The City Council is considering an ordinance to extend the "sunset" date from January 3, 2013 to July 31, 2013.


