Preliminary Final Plat Review

Preliminary Final Plat Review is an optional process to facilitate the timely recording of an applicant's final plat. This optional process allows the City to perform a preliminary review of an application prior to the completion of the required infrastructure and other improvements that normally required before a final plat application is accepted. The Preliminary Final Plat Review will produce a comment letter that will enable the applicant to make adjustments to their application materials final to full submittal.

Applications for Preliminary Final Plat Review may be submitted no earlier than 60 days prior to the planned submittal date for the full application for Final Plat.
