**AN RESOLUTION OF THE CITY OF SAMMAMISH CITY
COUNCIL APPOINTING MEMBERS TO A CITIZEN
ADVISORY COMMITTEE TO REVIEW POSSIBLE
REVENUE OPTIONS FOR PARKS AND RECREATION
PROJECTS**

WHEREAS, the City Council is committed to improving the quality of life for both residents and visitors by improving the current park system; and

WHEREAS, the City Council would like to explore different funding options for improving the park system; and

WHEREAS, in order to promote and facilitate public participation and involvement in the development of different funding packages and options the City Council is calling upon on its citizenry to assist in this important process; and

WHEREAS, the City Council finds that a Citizen Advisory Committee should conduct open public meetings to validate the project selections made by the Parks and Recreation Commission for possible revenue options for parks and recreation projects; and

WHEREAS, notice was provided to the community requesting interested persons to submit a letter of interest and resume to the City Council for consideration of appointment to the Committee; and

WHEREAS, the City Council has received and reviewed 8 expressions of interest;

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF SAMMAMISH, WASHINGTON, DO RESOLVE AS FOLLOWS:

Section 1. Formation of a Citizen Advisory Committee. The City Council hereby creates a Citizen Advisory Committee to assist in the validation of project selection for possible revenue options for parks and recreation projects.

Section 2. Appointment of Members. The Task Force members shall be those citizens designated in this resolution.
